

# PRIVACY POLICY

At Delta Global Solutions, we respect your right to privacy and take your data security seriously. This policy sets out how we collect and use your personal data through your use of [www.deltaglobalsolutions.com](http://www.deltaglobalsolutions.com) (“the Site”), including any data you provide us through our website.

The Site may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy statements.

## 1. TYPES OF DATA WE COLLECT

- 1.1. **Traffic Data.** We do not collect any traffic data directly. However, some of the services that we use, including Google Analytics, may collect data about your device type, IP address, web pages that you visit, time and date of your visit, duration of sessions, etc. Traffic Data is anonymous information that does not personally identify you but is helpful for marketing purposes or for improving your experience on the Site. By visiting our website, you understand and agree that your Traffic Data will be recorded. You may choose to disable cookies or discontinue using our website if you do not wish your traffic data to be tracked.
- 1.2. **Personal Data.** In order for you to download products that we offer via the Site or surveys we may ask you to do, we require you to provide us with certain information that personally identifies you (“Personal Data”). Personal Data includes the following categories of information:
  - (1) Identity Data such as your name, title, workplace, date of birth and gender
  - (2) Contact Data including your phone number, postal address, email address

## 2. HOW WE USE THE DATA COLLECTED

- 2.1. **Company Use of Data.** We use Contact Data to send you information about our Company or our products or services, or promotional material from some of our partners, or to contact you when necessary. We use your Identity Data to customize and tailor your experience on the Site, displaying content that we think you might be interested in and according to your preferences.
- 2.2. **Sharing of Personal Data.** We do not share your Personal Data with anyone nor do we sell it to any third party. However, we may disclose your Personal Data to comply with a legal requirement, such as a law, regulation, court order, etc.
- 2.3. **User’s Choice Regarding Collection, Use and Distribution of Personal Data.** You may choose not to provide us with any Personal Data. In such an event, you can still access and use much of the Site; however you will not be able to access and use those portions of the Site that require your Personal Data. If you do not wish to receive information and promotional material from us or from some of our partners, you may ask us in writing to “opt out”.

### **3. DATA SECURITY AND CONFIDENTIALITY**

- 3.1. The security of your Personal Data is important to us and we have put in place appropriate security measures to prevent your Personal Data from being accidentally lost, used or accessed in an unauthorized way.
- 3.2. The transmission and exchange of data is carried out at your own risk. We cannot guarantee the security of any data that you transmit to us, or receive from us. While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.
